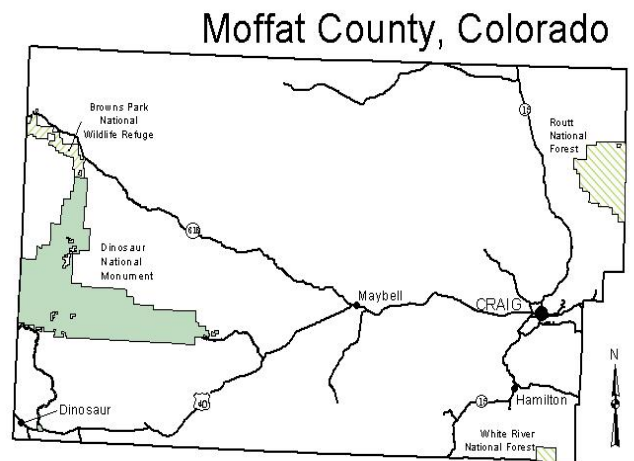


We serve the people of Moffat County
